

8. To accept to participate in shooting of any commercial television films and commercial photographs, arranged by the Promoter/Host Organizer; during the period of the contest. (in such case; any contestant participating in any commercials indicated above, will be entitled and be paid, percentage of the income obtained. These commercials can not be of kind, humiliating for the contestants).
9. To co-operate at all times and on all activities during the period of the contest.
10. Unless she is the winner or runner-up or she is required to stay by the promoter in the country where the contest is held or in such other country/ies for the post contest activities such as personal appearances, modeling, fashion shows and the like, the contestant will return to her place of embarkation within two days or the first available flight after the contest or as ticketed.
11. To be equipped with sufficient funds to cover incidental expenses such as; excess baggage charges air-port taxes, personal expenses and excess charges on item IV-3.

SPECIAL PROVISIONS:

1. If the contestant does not comply with the above, the promoter shall have the right to withdraw the contestant as one of the candidates and/or winners. In such event, she will leave the country where the contest is held, voluntarily immediately.
2. For the purpose of security control and re-confirmation of return air-tickets' reservations, all contestants and quests should deliver their passports and air-tickets, to the organization committee authorities, upon their arrival. Tickets and passports will be returned at the end of the contest.
3. All under aged contestants should have to submit, to the "Organization Committee", a "Letter of Consent" signed by their parents.

III. IF CHOSEN "MISS MODEL OF THE WORLD" OR RUNNER-UP

1. She shall not at any time thereafter commercially exploit her title in any way whatsoever except exclusively through and by sole agreement with the promoter/Host Organizer.
2. To conduct herself with decorum during the year of office and not to commit any act of an immoral, illegal or other similar nature which in the opinion of the Promoter will bring the contestant, " **MISS MODEL OF THE WORLD** " and to its title into disrepute, ridicule or contempt.
3. Immediately after crowning, she is obligated to enter into an exclusive contract with "**MISS MODEL OF THE WORLD**" Organization Committee to carry out engagements of personal appearances, modeling and advertising endorsements of the kind usually undertaken by the reigning Miss. Such contract shall be signed before the prize money/prizes are given to the winner/runners-up. If in any case, she will not fulfill her obligations as "**MISS MODEL OF THE WORLD** " during the year, the Promoter will take off the title from her and award and declare the first Runner-up as "**MISS MODEL OF THE WORLD** " she, therefore, will return, reimburse to Promoter/Host Organizer all money/prizes which have been awarded her, plus all other expenses which have been incurred by Promoter/Host Organizer in her behalf.
4. All winners (titleholders) and other contestants who will be elected by the organization committee, will have to stay and travel in Türkiye, or in Host Country, if required, for at least 7 (seven) more days, for the post contest activities. Such as; fashion shows personal appearances, press conference, courtesy calls and other functions, previously arranged by the Promoter/Host organizer. During this stay, the winners and contestants will be provided, with free transportation, hotel accommodation and meals.

IV. THE PROMOTER/HOST ORGANIZER UNDERTAKES TO THE CONTESTANT:

1. She will be met at the airport at the time of her arrival and be assisted at her departure.
2. That she will be provided with suitable hotel accommodation and meals during the entire duration of the contest. Meals are to be taken at a designated function room of the hotel or any hosted functions. Any other expenses incurred such as; room service, telephone calls, cigarettes, telegrams, cables, alcohol or liquor beverages will be to the personal account of the contestant.
3. To provide a bi-lingual or multi lingual chaperone for contestant for the entire period of the contest.
4. To provide transportation to all contestants to fulfill the contestant's itinerary and schedules.
5. To control, advice, assist, supervise and direct the contestant as to her conduct and well being during the contest.
