RULES AND CONDITIONS OF PARTICIPATION

I. STANDART CRITERIA:

1. Shall have attained the age of 18 years old on or before but shall not exceed the age of 26 years old.
2. Must stand at least in height
3. Must have been elected by the National Sponsor as National Contestant or runner-up (if winner is unable or unfit to qualify)
4. Must have good moral character and posses poise, charm, personality and beauty of face and figure.
5. Must be single.
6. Must have experience in Fashion Modeling and Photo-Modeling.

II. THE CONTESTANT WARRANTS AND UNDERTAKES:

1. To arrive in Istanbul- Türkiye or the country where the contest will be held on 19
2. To be fully equipped with suitable wardrobe to be used during the period of contest, to include:
 - 1) One (1) National Costume (Very important)
 - 2) One or Two Evening Gowns
 - 3) Casual clothes
 - 4) Personal Swimsuits and other beach wear.
 - 5) Formal and Informal Dresses
 - 6) Suitable Shoes and Accessories for the above.
3. To conduct herself properly during the period from her arrival in Istanbul. Türkiye/host organizer's country up to her time of departure after "MISS MODEL OF THE WORLD" contest.
4. Willing to obey and comply at all times during the period of the contest and to keep with the Promoter's/Host Organizer's Official party/functions at all times during the period of the contest and not otherwise leave the hotel (without permission from the promoter/Host organizer and chaperone).
5. Not to accept private engagements during the period of the contest.
6. To allow and permit Promoter/Host Organizer to use or take photographs of the contestant for the purpose of publicity and promotion of the contest.
7. To appear on television, radio, film, fashion shows or print media for purposes of publicity and promotion of the contest. (This also includes wearing swimsuits and bikini as well).
